- 1. The Player agrees that he will attend all ice practices, games, off-ice training, instructional sessions and organized team meetings, except when prevented from doing so for educational obligations or medical reasons, in which case, the Player will request permission, **in advance**, to be absent, when reasonably possible to do. The Cherry Hill East Ice Hockey Club acknowledges that such permission will be granted for all reasonable requests. The Player agrees that he/she will maintain his academic and educational course work at the highest-level possible.
- 2. The Club shall purchase ice time for practice sessions and games throughout the season.
- 3. The Club will secure coaching for each team.
- 4. The Club does not guarantee equal playing time to the Player as a condition of membership.
- 5. The Parent will make certain prior to their child's participation in the activities of the Club that the child is in good physical health.
- 6. The Parent will provide their child with all necessary HECC approved equipment to participate in the game of ice hockey and to make certain the equipment is maintained in good order.
- 7. The Parent shall be obligated to pay the Club tuition as established in the Club's Payment Policy
- 8. The Parent and Player acknowledge and agree that failure to pay the full fees in a timely manner as established in the Club's Payment Policy may result in Player's suspension from all Club activities and/or discharge from the Club without recompense. Any other payment arrangements must be approved by the Cherry Hill East Ice Hockey Club Board.

- 9. The Player and Parent acknowledge and agree that the full fees must be paid, even should the Player or Parent determine to voluntarily leave the Club or the Player be discharged from the Club, subject to Club's current refund policy.
- 10. The Player will wear all required protective equipment at all times when participating in on-ice activities.
- 11. The Player and Parent will immediately report any injuries or medical conditions from which the Player suffers to the team head coach.
- 12. The Player and Parent agree to abide by all rules and regulations of USA Hockey, the South Jersey High School Hockey League, the South Jersey Middle School Ice Hockey League and the Cherry Hill East Ice Hockey Club.
- 13. The Player and Parent acknowledge that failure to abide by the rules set forth in this agreement and addendums will be cause for disciplinary action up to and including dismissal, without refund, from the Cherry Hill East Ice Hockey Club. Further, Player or Parent will not commit any act detrimental to the Club or to the sport of youth ice hockey. Such infractions may lead to suspension or termination of the Player.
- 14. The Player and Parent acknowledge that ice hockey is a contact sport. The Player and Parent agree that neither the Cherry Hill East Ice Hockey Club, nor any of its officers, agents, servants, employees, and sponsor shall be held liable for any injury or damage resulting directly or indirectly from and participation with the Club, whether such participation occurs on or off the ice. The Player and Parent further agree that they hereby discharge the organization, its officers, agents, servants, employees and sponsors from any and all actions, claims, and demands for injury or damage. It is understood that said release and discharge shall bind the heirs, legal representatives, successors, and assigns of the parties to this agreement. It is further agreed the Cherry Hill East Ice Hockey Club shall not be considered a guarantor of the safety of any equipment or facility provided for the benefit of both Player and Parent. The Cherry Hill East Ice Hockey Club reserves the right to use any pictures taken during activity for promotional or instructional purposes without compensation to either Player or Parent.
- 15. Any player that is a senior that receives a suspension that cannot be served due to limited games available could be assessed a fine of \$250 (dictated by the league).
